## WASHINGTONIAN MAGAZINE'S "TOP LAWYERS" FEATURES WLF BOARD MEMBERS, PRO BONO ALLIES

These attorneys' fields of practice focus on matters that significantly impact America's free enterprise system, such as white collar criminal defense; securities litigation and regulation; antitrust; environmental enforcement; food and drug regulation; and Supreme Court advocacy.

"We are fortunate and proud that these highly respected practitioners have donated their time and expertise to support WLF's mission of promoting freedom and free enterprise," said Daniel J. Popeo, WLF's Chairman and General Counsel. "WLF devotes its limited resources to a wide range of issues that affect free enterprise, and we would not be able to effectively advocate in the courts and other legal policy making bodies were it not for the *pro bono* support we get from our national network of legal experts," Popeo added.
